AUCTION NOTICE

Subject: Disposal of seized unclaimed vehicles.

Under Rule 109A of Assam Motor Vehicle (Amendment) Rule 2023, office of the District Transport Officer, Karbi Anglong, Diphu, is proposing to scrap 15 (fifteen) number of seized unclaimed vehicles on "as is where is basis".

Accordingly, sealed quotations affixing court fee stamp of Rs 8.25 (Rupees Eight and twenty five paise) only are invited from RVSF for scrap of the said vehicles on the terms and conditions mentioned below.

1. Registered Vehicle Scrappage Facility (RVSF), interested in purchasing the above mentioned vehicles, may submit their highest bid in the enclosed Proforma in a sealed cover addressed to the undersigned latest by 3.00 P.M on or before 21st January 2026 at the Office of the District Transport Officer, Karbi Anglong, Diphu and will be opened on the same day at 3.05 PM. The Bidder or their representatives, not more than one for each quotation, may be present, if they so desire, at the time of opening of the Quotations.
2. For inspection of the vehicles, Mr Bitupon Changmai, MVI may be contacted between 2.00 PM to 3.00 PM on working days.
3. The Auction of the said vehicle will be governed by the following conditions –
 - i) The vehicle will be sold on "as is where is basis". The auction process will be conducted in presence of the constituted Standing Committee for Auction of Seized Vehicle.
 - ii) The successful highest bidder will be required to deposit the bid amount by means of Demand Draft.
 - iii) 25 (Twenty five) percent of purchase money shall be paid within 7 (seven) days from the date of sale. In default of making such payments, the vehicle shall be sold to the next highest bidder.
 - iv) On payment of Purchase money, the authorized officer shall issue a receipt for the same and the sale shall become absolute. He shall also cause the vehicle to be delivered to the purchaser.
 - v) The vehicle will be disposed off on "as is where is basis" and no guarantee for its worthiness or quality will be given by the department.
 - vi) The Bid amount is excluding GST, as the GST is to be paid by the recipient of the goods as per the rates applicable.
 - vii) The Standing Committee reserves the right to accept or reject any/all of the quotation without assigning any reason.
